Requirements:

1. Applicants must reside within a reasonable commuting distance of the Sheriff's Office.
2. Applicants must not be less than fourteen (14) or more than twenty-one (21) years of age.
3. Applicants must attend school, have graduated from school, or have passed a high school level General Education Development (GED) test.
4. Applicants must have a good moral character and must not have been convicted of a crime for which punishment could have been imprisonment in a Federal Penitentiary or State Prison.
5. Applicants must not be on any type of law enforcement probation or academic probation.
6. Applicants must have a background investigation completed prior to appointment.
7. Applicants must appear before an Explorer Post membership committee for an oral board interview.
8. The work features learning opportunities, which include observing and assisting in the performance of routine law enforcement and crime prevention, such as patrolling assigned areas, booking and escorting prisoners, receiving and answering complaints, serving as a jailer, and performing other law enforcement duties with the presence of a regular employee of the department.
9. Each explorer will be on a one (1) year probationary period. During this period he/she is required to spend twelve (12) hours in dispatch prior to patrol ride-a-longs.
10. Each Explorer will be required to volunteer at least eight (8) hours per month average for the Sheriff's Office.
11. Each Explorer is expected to attend regular monthly meetings as scheduled.
12. Each Explorer must purchase a regulation uniform, leather gear, and black shoes or boots prior to the end of the probationary period. The cost of the uniform is approximately \$125 to \$150 and is not reimbursable.
