Under general supervision, troubleshoots, maintains, and does minor repairs on emergency vehicles and equipment; operates and maintains a variety of hand, power, and shop tools.

## **Examples of Duties**

- Performs minor equipment repairs and maintenance tasks, including locating and diagnosing mechanical defects;
  performs minor repairs on various types of motors and valves, gasoline, and diesel engines, referring more complex repair needs to outside contractors for completion.
- Maintains records on maintenance and repair work performed, work orders, and inspection reports.
- Ensures the proper usage, maintenance, repair, and storage of all tools and equipment.
